1. Disabled guests are welcome to enter with their own wheelchairs and three or four wheeled electric convenience vehicles (ECV) providing the individuals produce current handicap credentials.
2. Exceptions to this policy will be considered on a case by case basis for disabled persons without ECV who have their own properly insured golf cart, ATV, moped, scooter, etc.
3. A properly insured golf cart, ATV, moped, scooter, etc. consists of:
  - a. Verification of current state credentials and current handicap permit
  - b. Valid liability insurance coverage on handicap vehicle (golf cart, moped, ATV, scooter, etc.)
  - c. Homeowner's or business insurance policy
  - d. One million or more valid liability insurance coverage
  - e. Big Butler Parts a Rama must be listed on insurance policy as "additional insured" with event dates and locations.
4. Handicap person must be on the vehicle at any time that it is in use as a driver or passenger with one caretaker driving.
5. Signed permit affixed to handicap vehicle
6. Owners/Drivers assume all vehicle damage and liability

My signature verifies that I have read and understand the requirements for operating a handicap vehicle and that I assume all vehicle damage and liability and that Big Butler Parts a Rama, Butler Fair and Agricultural Association and each and every other person or entity in any way connected with Big Butler Parts a Rama event will not be liable nor responsible for any injury to persons nor damage to property at any time from any cause whatsoever and Big Butler Parts a Rama, Butler Fair and Agricultural Association and each and every other person or entity in any way connected with Big Butler Parts a Rama event shall be held harmless from any and all liability, verdicts, judgments, damage to persons or property and shall indemnify Big Butler Parts a Rama, Butler Fair and Agricultural Association and each and every other person or entity in any way connected with Big Butler Parts a Rama event for all costs, expenses, judgments, verdicts or attorney's fees resulting therefrom. I understand that this permit may be revoked at any time should the management of the event determine that the privilege to use the above identified motorized vehicle during this event has been abused in any fashion whatsoever.
